Better healthcare where and when you need it

Delivered



Based on the success of the Belconnen and Tuggeranong operating models, three additional nurse-led walk-in centres in Gungahlin, Weston Creek and Dickson have been opened.

Strengthened mental health and wellbeing support

Twenty psychology positions have been established permanently since 2018 plus five additional psychologists at the start of the 2020 school year to strengthen mental health and wellbeing support in our schools.

Protecting our environment

Over 4,000 new trees will be planted by the end of the 2019-20 financial year and by 2022-23 over 20,000 more trees will be planted in total to expand the urban and street shade canopy and replace ageing trees.

With Light Rail Stage 1 (Gungahlin to City) successfully delivered, construction work is expected to start in 2021 on the Light Rail 2A (Alinga Street to Commonwealth Park).

As the new network rolls out, the Government is continuing to add supporting facilities like Park & Ride carparks, bike lockers and cages at key destination points.
