- Implement the Senator's campaign strategy, including:
  - development and actioning of a state-wide and national community engagement plan complete with both online and off-line participation opportunities
  - online and off-line community engagement activities targeted at strategically identified communities.
  - Supporter engagement and activation pathways utilising email and direct messaging.
- Build mutually beneficial relationships (online and offline) within strategically identified communities

- Work with the Senator and their team to develop an integrated Community and Constituent Response Strategy covering all forms of community contact including email, letters, direct messages via senators social media accounts, comments via social media accounts
- Work with the Chief of Staff to ensure people are able to engage in the Royal Commission into Violence, Abuse, and Neglect of Disabled People. Including advising the public on pathways to make a submission and building relationships with disability community advocates and organisations.
- Liaise with national and state campaigners on the national campaigns to build mutually beneficial relationships that progress the Senator's campaign priorities.
- Identify campaign opportunities that support parliamentary work and parliamentary opportunities that will support ongoing campaigns.
- Assist with the administration of Printing and Communications budget in line with the campaign strategy and community engagement plan.
- Attend and/or represent the Senator at party meetings, community meetings, and public engagements as required.
- Work in accordance with Occupational Health and Safety Processes, the Access and Inclusion Processes, and other workplace compliance policies and practices.
- Other tasks as directed by the Senator or Chief of Staff.

- You have the ability to organise online and offline community engagement opportunities and events.
- You have leadership skills, you'll be able to lead and inspire people to understand the
  possibilities of people-powered change.
- You share our team values and have a commitment to The Australian Greens Principles and Charter.

- You have an ability to understand the Australian political context and experience being involved in advocacy, non-profit or community organisation.
- You're able to work flexible hours including evenings and weekends and are able to undertake occasional travel in WA and interstate.
