

# Tasmanian Greens Party Policy 2014

# Justice

[RATIFIED: 18 JAN 2014 - VERSION: 14.1.0]

The Tasmanian Greens believe in a just, tolerant and fair society that provides equal opportunity to all people. It is the right of every individual to live with dignity, free from discrimination on the basis of their physical or mental attributes, appearance, or past experience.

The Greens will ensure that acceptance of difference amongst individuals is directly encouraged and supported, particularly by the media and education systems.

We recognise the need for strong, independent, properly and publicly resourced bodies to oversee the accountability of public institutions and corporations to increase accountability in public areas.

The Greens will maintain a strong Anti-Discrimination Act and legislate to provide equality for all Tasmanians under the law, regardless of race, gender, marital status, sexuality, religious belief, political affiliation, disability, age or culture, with all Tasmanians having adequate access to legal services.

## Measures

#### **Child Protection**

The Tasmanian Greens will work to:

- 1. investigate the nature and extent of past abuse of children and recommend further legal and compensatory action;
- 2. update legislation, regulation and government departmental practices to minimise child abuse in the future;
- 3. maintain support for the Office of Child Protection;
- 4. maintain support for the Office of the Commissioner for Children;
- 5. support the work of the Royal Commission into Institutional Responses to Child Sexual Abuses.

#### **Drugs Use**

The Tasmanian Greens will work to:

- 6. uphold criminal penalties, including imprisonment, for the supply of illicit drugs and the possession of illicit drugs above quantities consistent with personal use;
- 7. legislate civil sanctions for the personal use of illicit drugs to include diversion programs, compulsory treatment, education programs and penalties;
- 8. provide increased availability of diversion to rehabilitation, treatment and recovery programs as a sentencing alternative for people convicted of possession for personal use;
- 9. remove advertising promotions of alcohol in sport;
- 10. ban advertising promotions that target young people, or encourage excessive drinking;
- 11. tax alcoholic beverages based on alcohol content.

#### Public Protection

The Tasmanian Greens will work to:

- 12. extend and upgrade current legal protection given to those who legitimately report the improper or illegal activities of governments, government departments, non-government organisations and private corporations;
- 13. legislate to prevent corporations from initiating litigation designed to dissuade or prevent participation in public debate;
- 14. provide for an Ombudsman funded independently of the Department of Justice and detached from it;
- 15. establish a separate, independently resourced office of the Medical Complaints Commissioner;
- 16. establish a Community Services Commission to investigate and report on the quality, effectiveness and standards of government-funded community services.

### Same Sex Marriage

The Tasmanian Greens will work to:

- 17. remove all discrimination and provide transgender, bisexual and intersex people with access to the same cultural and legal institutions as other Tasmanians, including the institution of marriage;
- 18. repeal any state laws or regulations which discriminate against gay, lesbian, bisexual, transgender and intersex people.

#### Anti-Corruption

The Tasmanian Greens will work to:

19. provide adequate powers to the Integrity Commission to enable it to act as an effective, independent commission against corruption.

#### Prison Reform

The Tasmanian Greens will work to:

- 20. fund community-based correction services to reduce prisoner numbers and provide noncustodial sentencing options for judges and magistrates;
- 21. fund comprehensive prisoner reintegration programs;
- 22. legislate to give the fundamental democratic right to vote in elections to all people serving custodial sentences, but consult the Law Reform Institute and the Human Rights Commissioner as to who is given the power to rescind that right in case of particularly heinous crimes;
- 23. establish an independent inspectorate of prisons, responsible to Parliament, with the capacity to conduct unannounced visits to all custodial institutions in Tasmania, and make recommendations to Parliament regarding reform.
